## CRAFT FAIR / GARAGE SALE / FLEA MARKET PARTICIPANT RULES

**\*\*\*OUTSIDE SPACE ONLY\*\*\***

**\*\*\*YOU MUST PROVIDE YOUR OWN TABLES, CHAIRS, TARPS, etc.\*\*\***

*Absolutely NO firearms, and NO pets allowed. Flea markets welcome. No food should be sold for consumption, bulk food products are allowed. All items must be legal and lawful.*

**Set-up Hours:** Saturday, 8:00 a.m. to 9:30 a.m. All vehicles must be unloaded and moved by 9:30 a.m.

**Set-Up & Check-in:** Please check in before setting up. Each participant will have a 10' x 20' space.

**Parking:** You may bring your car to your space to unload. You may park in your space as long as you do not exceed the 20' limit. All extra vehicles must be moved away by 9:30 a.m. on the day of the show. There will be a reserved parking area for participants.

**Food Concessions:** There will be food and beverages available between 10:00 am and 3:00 pm.

**Pre-Registration** Register by June 8th to receive the \$20 / \$50 rate. After that the price is \$30 / \$60

**Clean-up:** Take Your trash and unsold items with you! All trash and unsold items must be packed up and removed when you leave.

**Casual Seller:** New York sales tax law exempts a casual sale. A casual sale is a one-time or occasional sale of property acquired by the owner for personal use and the owner does not regularly sell that type of property. Example: A homeowner selling clothes or toys outgrown by his or her children at a garage sale or a flea market is a casual sale and exempt.

**Registered Business:** Those who have a regular business or do sales on a regular basis must collect sales tax. The sales tax number can be obtained by visiting [www.irs.gov/business/small](http://www.irs.gov/business/small). Please list your tax id# if applicable.

**Retail Businesses:** Those who own a retail business may call the Chamber at 563-1000 for participating info. Class sponsorships are available for retail businesses. You will receive premium vendor space, as well as many other benefits.
