LIABILITY: It is agreed that the exhibitors shall assume all responsibility for any loss, damage, or injury that they shall have or cause and that they shall indemnify and hold harmless the North Country Chamber of Commerce, and the State University of New York at Plattsburgh and its officers, directors, or employees from all liability which may ensue, from whatever cause. Exhibitors bear all risk and expense for any loss, theft or damage to their booth and its contents, and to bear the risk of injury to myself and those working with them. Guard service will be provided during those hours when the show is not open to the public only, and every precaution will be taken to protect the exhibits. However, the North Country Chamber of Commerce and SUNY Plattsburgh do not guarantee loss of any kind.

PROTECTION OF EXPOSITION HALL: Nothing shall be posted, tacked, nailed, screwed, or otherwise attached to columns, walls, floors, drapes or other parts of the building, decorated materials or furniture. Exhibitors violating this regulation are express bound, at their expense, to repair any such damage to the exposition hall at SUNY Plattsburgh. SUNY Plattsburgh may at their sole discretion select the contractor to repair any such damage and authorize the contractor to proceed with the repairs without prior notification to the exhibitor.

Helium Balloons Are NOT permitted.

FIRE PRECAUTION: Combustible decorations and flammable chemicals cannot be used in any manner by any exhibitor. All packing containers, excelsior, and similar materials are to be removed from the floor upon completion of the booth set-up.

PAYMENT: A minimum non-refundable deposit of \$100 must accompany the registration form! Application will **NOT** be processed without \$100 deposit! Balance of payment (including electrical fees if any) is due **no later than May 19, 2017.** To receive the Chamber Member Discount, Chamber dues *must* be paid. Please make checks payable to the North Country Chamber of Commerce.

Every exhibitor must supply the Chamber of Commerce with an Insurance Certificate that establishes the following insurance is in force and effective for the period of the exhibition:

-General liability and premises operations, including bodily injury and property damage in a minimum amount of \$1,000,000. *The Plattsburgh - North Country Chamber of Commerce must be listed as Certificate Holder and Additional Insured on this Certificate of Insurance.*

-Workmen's compensation and disability benefits as required by the State of New York.

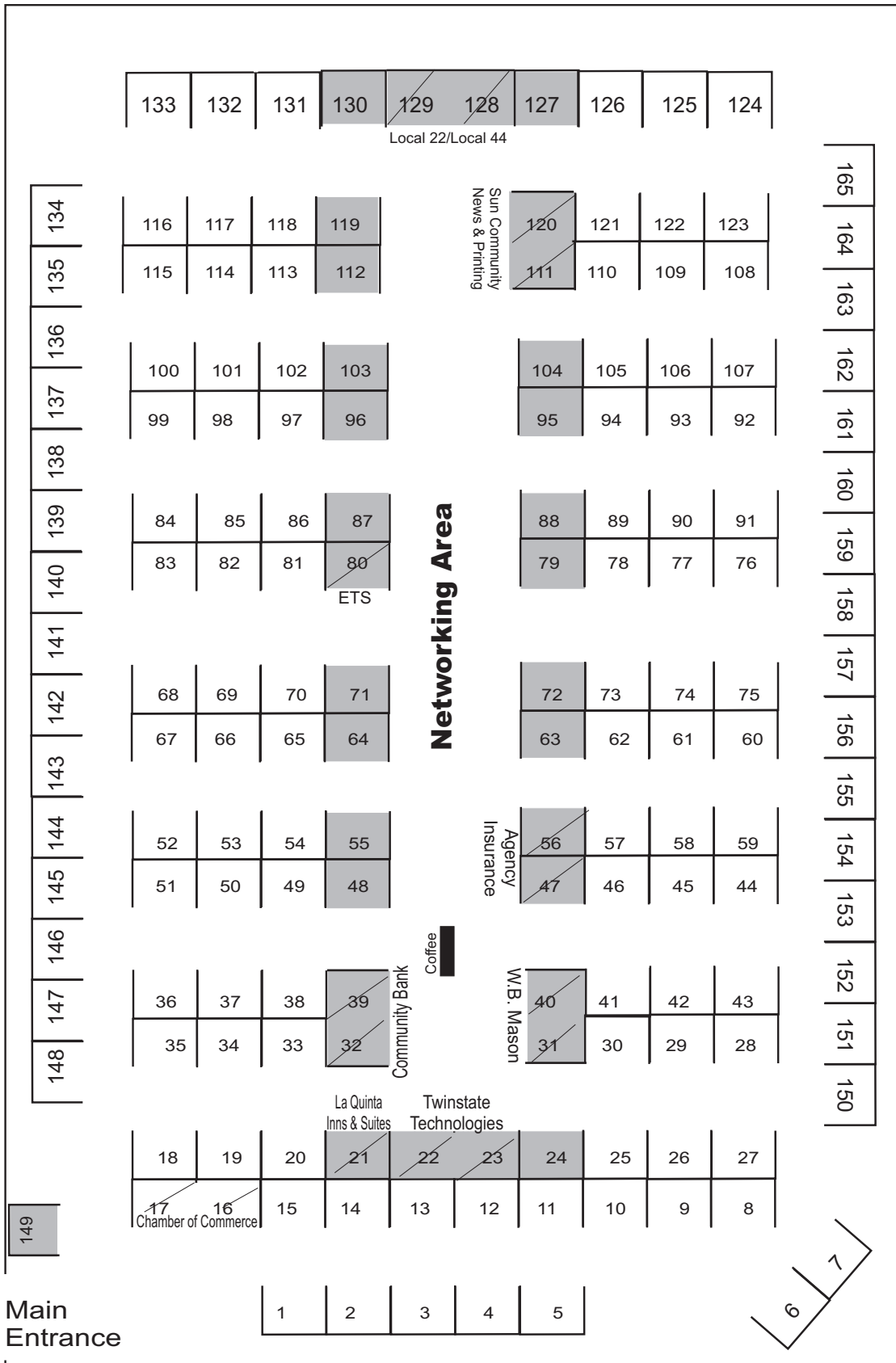
